## VENDOR RULES AND INFORMATION

**TAXES & PERMITS:** It is the vendor's responsibility to collect and pay any required local and state taxes. All food vendors are responsible for maintaining the necessary health department permits, as required by law.

**BOOTH SPACE:** Booth spaces are approximately 12'x12'. Due to physical space limitations, we reserve the right to limit the number of booth spaces. Vendor Booth Space applications are subject to the approval of the Car & Bike Show Committee. We reserve the right to refuse any entry.

**Merchant Booth Location:** 74 East Commercial St. (Willits City Hall/Community Center Parking Lot) Corner of East Commercial/Marin St.

**Food Vendor Location:** Bud Snider Park (across the street from Willits City Hall/Community Center, in the City Park)

### **VENDOR RULES AND RESPONSIBILITIES:**

- Completed Vendor application on form and liability waiver must be received by May 21, 2026 – unless registration is closed due to maximum capacity reached prior (whichever comes first).
- Tables, chairs, canopy, signage, trash cans etc. to be provided by vendor.
- Quiet generators are allowed.
- Booths MUST BE set up no later than 10am (unless prior arrangements have been made).
- You can park near the booth for set-up but then please move your car. Do not park on the perimeter of Bud Snider Park. These parking spaces will be used for car exhibitors.
- Vendors may not begin dismantling before 3pm or leave early.
- Vendor space may be revoked if the vendor does not comply with these rules and responsibilities.
- No water exhibits are allowed.
- The 44th Annual Car & Bike Show Committee reserves the right to request proof of liability insurance from any vendor before approving an application.
